Rule 144 ("SEC Rule 144") under the Securities Act of 1933 ("Securities Act") provides a safe harbor from the registration provisions of the Securities Act for resales of restricted and control securities by persons other than the issuer if all conditions of the rule are complied with. Section 4(a)(1) of the Securities Act (formerly Section 4(1) but redesignated Section 4(a)(1) by the JOBS Act) provides an exemption from registration under the Securities Act for transactions by any person who is not an issuer, underwriter or dealer. Sometimes known as the "ordinary trading" exemption, Section 4(a)(1) is a commonly used resale exemption.

One of the earliest and significant Review Commission decisions pertaining to Section 4(b)(1) was Fineberg Packing Co., 1 OSHC 1598, 1973-74 OSHD 17,518 (1974), in which the Commission held that OSHA's standards applicable to the handling and processing of meat products was not preempted under Section 4(b)(1) of the OSH Act because the purpose of the other agency's statutory authority, the Wholesome Meat Act, was not to protect workers but to protect consumers.
